I. RESEARCH METHODOLOGY

The Roundtable conducted an inventory of units housed in finance and operations divisions, or their equivalent, at the 17 institutions designated as peers by the University of Tennessee-Chattanooga (UT-Chattanooga). The information in this report is based on units, staff, and budgets identified in organizational charts, division websites, budget documents, and correspondence with staff at the following institutions:

Throughout this report, unavailable information has been designated with a single hyphen ("-").

II. KEY OBSERVATIONS

- ❖ The most common units located within finance and operations divisions across profiled institutions include human resources; facilities management and planning; and an accounting, financial reporting, or controller unit. Units such as public safety and information technology services report to finance and operations less frequently (at less than half of profiled institutions). In addition, most profiled institutions house facilities management and planning units within the finance and operations division.
- **❖** Across profiled institutions, finance and operations divisions are typically led by one vice president or vice chancellor, an average of two associate vice presidents or chancellors, and an average of five directors.
- Human resources units at profiled institutions are led and supported by an average of one director -level staff, an average of four assistant director-level staff, and an average of eight non-management staff.

- **❖** Information technology units at profiled institutions are led and supported by an average of three director-level staff, an average of two assistant director-level staff, and an average of 33 non-management staff.
- **❖** Plant operations units at profiled institutions are led and supported by an average of one to two director-level staff, and an average of one assistant director-level staff.
- ***** Business operations units at profiled institutions are led and supported, on average, by less than one director-level staff, less than one assistant director-level staff, and three non-management staff.
- ❖ Business and finance units at profiled institutions are led and supported by an average of one director-level staff, an average of two assistant director-level staff, and an average of seven non-management staff.

III. UNITS REPORTING TO FINANCE AND OPERATIONS DIVISIONS

Although organizational structures vary widely across profiled institutions, the following units correspond roughly to the seven primary functional areas of the finance and operations division at **UT-Chattanooga**.

IV. MANAGEMENT STAFF IN FINANCE AND OPERATIONS DIVISIONS

The chart below inventories the frequency of upper- and mid-level management across finance and operations divisions, along with the budgets of those divisions. The inventory is based on staff information available on organizational charts or division websites and budget documents at the 17 identified profiled institutions. It is noted that three of the four positions for UTC slated in AVP/AVC/Chief Officer roles were promoted from Director level positions to AVC positions with years of service ranging from 19 to 30 years.
